What does the municipal valuation mean?

The Dorset municipality has recently undergone a property revaluation, and property owners should have received a fresh valuation notice over the last few weeks. While the council will not increase overall rate revenue beyond what is necessary when setting the 2024/25 Annual Plan and Budget, the revaluation redistributes the rates among various property classes—Residential, **Primary** Production, Commercial, Industrial, Community Services-and locations such as Scottsdale, Bridport, Derby, Branxholm. Ringarooma, Gladstone, Winnaleah, and Pioneer. Rate modelling using the new valuation data is conducted as part of the budget process to ensure fair distribution across



the municipality. The Local Government Act provides tools to allow council to moderate the rate calculation to ensure they are reasonable for the majority of ratepayers.

The Office of the Valuer-General has revalued all properties in the Dorset municipality. Under the Valuation of Land Act 2001, Tasmanian properties are revalued every six years. This process determines three values for each property: Land Value, which excludes visible improvements; Capital Value, which includes land value and improvements but excludes plant and machinery; and Assessed Annual Value, which is the gross annual rental value, not less than 4% of the capital value.

If you disagree with your valuations, you can lodge an objection within 60 days of receiving the notice. Visit www. nre.tas.gov.au/ovg to file an objection online or download an Objection to Valuation form. There is no cost for filing an objection, but hiring a solicitor or agent will be at your expense.

Objections must be based on one or more of these grounds: the valuation is too high or too low, interests in the land are incorrectly apportioned, incorrect apportionment of the valuation, properties should be valued together or separately, the named owner is incorrect, or the land details are incorrect. You cannot object due to increased land tax or council rates.

Depending on your objection, you may need to provide comparable market sales or rental data, title or survey plans, or evidence of property changes. Property sales information is available for a fee at www.thelist.tas.gov.au. Market evidence can also be obtained from real estate agents.

If any details are incorrect, contact the Office of the Valuer-General via www.nre. tas.gov.au/ovg. The site offers options to update your postal address, lodge a general enquiry, or file an objection.

Property values are based on market sales and rentals. Changes in the market or your property can result in new valuations. These valuations help calculate council rates, land tax, and government rental fees for Crown land use.

The Valuer-General manages statutory valuations in Tasmania, conducted by appointed contractors. Property valuers use market data and inspect properties to ensure accurate valuations.

The occasion demonstrated the success of this local business that had become a Scottsdale institution.

Shirley and Rod opened their small Art Gallery on Alfred Street, Scottsdale in 2005. They later expanded their business to include framing services where Rod honed his skills and became one of the best of this trade in the State. Shirley completed her studies in Arts Administration and later obtained a Masters of Contemporary Arts. They were then ready to expand their business further and combine and offer their skills to the community, so in 2007 they purchased a new property on King Street which needed renovations.

During the renovation period, they moved their Gallery to Victoria Street, where their business flourished and was supported by local and Tasmanian artists. As the renovations were taking place, time was precious for the couple; Rod was working with Auspine and Shirley was working as an Authorised Marriage Celebrant. With all the busyness of organising maior renovations, running Gallery and working on the side, it was a wonder they survived. But they did. Working together with architect Cath Kilner, they designed and completed an amazing building that had great lighting and wall space to display the wonderful art that was to come.

In January 2010, the Scottsdale Art Gallery Café on King Street was opened. The Café was added to compliment the gallery business, understanding that good coffee is a must when surrounded by beautiful artwork. Years later, they branched out again, offering bike hire to accommodate the Rail Trail.

To date, Shirley and Rod's Gallery Café has hosted up to 200 events and exhibitions including exhibitions from local and Tasmanian artists, family events, community functions and meetings, Pudding Nights and, we must not forget, the Becoming Famous For Our School Students, which showcased North East students' amazing talents and expressive This event was a yearly artwork. showing that Shirley and Rod took pride in and enjoyed immensely.

After 14 years of offering a



welcoming smile, delicious food, great coffee and exceptional service, it is time to say farewell to the proprietors of Scottsdale Art Gallery and Café on King Street and thank Shirley and Rod for all they have given to the community, their outstanding support and guidance to organisations and endless hours of dedication and determination, for which they are commended.

On behalf of the Chamber of Commerce, I would like to wish Shirley and Rod the very best for their next stage in their future and with any new endeavours, and to enjoy time together to have a coffee and relax. Thank you for setting a wonderful example and to show us such success is possible.

Minimum Wage increase from July 1

The Fair Work Ombudsman is reminding employers that a 3.75 per cent minimum wage increase should be applied to eligible employees' pay from the first full pay period starting on or after July 1, 2024.

The new National Minimum Wage is \$915.90 per week (based on a 38-hour week for a full-time employee), or \$24.10 per hour. The rates have increased from \$882.80 per week and \$23.23 per hour. Casual employees entitled to the National Minimum Wage must receive a minimum \$30.13 per hour, which includes 25 per cent casual loading.

The National Minimum Wage is the base rate for adult employees in the national system who are not covered by an award or registered agreement.

The 3.75 per cent increase also applies from the first pay period starting on or after today to the minimum wage rates within awards.

Energy bill relief for businesses

Small business customers who get their electricity from an embedded network can now access energy bill relief offered by the Tasmanian Government.

The Supercharged Renewable Energy Dividend Program 2024 for small businesses on embedded networks provides a one-time payment of \$300 for eligible small businesses.

To access the payment, businesses must show that they are on an embedded network, meet the elegibility criteria and submit an application before October 31.

An embedded network exists when businesses receive their electricity from a landlord building owner or entity that purchases the power from a retailer and on-sells itto them through a metered connection.
